Minutes of the Committee constituted vide notification No.UOM/Acad/20/486 dated 05-Jan-2021

In pursuance of the decision of the Academic Council made in its 13th meeting held on 15-Oct-2020 (vide Item No.02) notified vide No. UOM/Acad/20/486 dated 17-Nov-2020 (Annexure-A), a series of meeting of the committee were held on 18-Dec-2020, 05-Jan-2021, 19-Jan-2021, and 25-Jan-2021. The Committee, after mutual consultation, developed an illustrative table pertaining to semester breakup appended herewith as Annexure-B for onward circulation amongst the departments for guidance and further necessary action at their end. The committee, after marathon deliberation, recommended as under:

- a) Heads of all Teaching Departments should go through the Higher Education Commission (HEC)'s Undergraduate Education Policy 2020 (UEP-2021) to initiate necessary steps forthwith for revising the existing BS (4 Year and 5year) Programs in order to bring them in line with the UEP-2020 (available at UOM website) through their respective bodies for onward submission to the Academic Council for consideration/further necessary action in order to ensure implementation of the policy from Fall semester 2021;
- b) Each department shall process its 2-Year Associate Degree Program (already designed and made available at the UOM website) through the relevant bodies for consideration of the Academic Council for further necessary action. The courses pertaining to General Education as reflected in the aforementioned framework should be processed through the relevant bodies by the respective departments and courses codes should be given to them by the parent department according to the already approved format of the University;
- c) Minimum credits should be <u>65 for the 2-Year Associate Degree program</u>, <u>130 for the 4-Year BS</u> program, and credits for 5-Year BS programs should be in accordance with the requirements of the respective councils;
- d) A Career Development Center may be establish to ensure that academic advice is available to every student as required under paras 12 and 30 of the UEP-2020; and
- e) Each department shall designed a comprehensive program in order to meet the Practical Learning requirements of the students as stipulated in Paras 09, 24, 25, 26 and 27 of the UEP-2020.

Reference is made to the Executive Director, Higher Education Commission (HEC), Pakistan's letter No.10-1/A&C/HEC/2021/19 dated 15-Jan-2021on the subject captioned above and to state that PDF version of Undergraduate Education Policy (UEP) 2020 which was received to the University vide letter No.1-32/PERU/UGE Policy/HEC2018 dated 12-Aug-2020 and the same was placed before the Academic Council. The Council in its 13th meeting held on 15-Oct-2020 (vide Item No.02) constituted a committee notified vide No.UOM/Acad/20/486 dated 17-Nov-2020 to go through the UEP 2020 for clarification of any aspect of the policy from the quarter concerned of HEC and to submit its report/recommendations to the Vice Chancellor for perusal and onward circulation amongst the teaching departments for necessary action thorough laid down procedure at their end. The committee submitted its recommendations including an illustrative template (duly approved by the Hon. Vice-Chancellor) which are enclosed herewith for your kind information/guidance and further necessary action.

It is worthwhile to mention that in pursuance of the directives of the Government of Khyber Pakhtunkhwa concerning launching 2-Year Associate Degree Program in place of B.A/B.Sc in Non-BS affiliated colleges from the academic session 2020, the University of Malakand has designed a comprehensive Framework for the purpose. The Syndicate in its 36th meeting held on 19-Dec-2020 [vide Item No.3(7)] allowed the 2-Year Associate Degree program in 23 disciplines/subjects and directed that the already designed courses, credits, eligibility criteria, pathway to further education and other related matters should be brought through the respective authorities after approval of the Undergraduate Education Policy-2020 (notified vide No.UOM/Acad/21/39 dated 25-Jan-202. Further to mention for your kind information that the affiliated colleges (Non-BS) have started the aforesaid programs from the academic session Fall-2020.

The Undergraduate Education Policy 2020 (printed versions), the 2-Year Associate Degree (AD) Framework (for Non-BS affiliated colleges), minutes/recommendations of the Committee, illustrative template for semester break up as well as related notifications/letters of the Higher Education Commission, Islamabad and the Government of Khyber Pakhtunkhwa have been uploaded on the UOM website available at link (www.uom.edu.pk/ade.php) for information/guidance and further necessary action.

Foregoing in view, it is requested to initiate necessary steps forthwith for revision in the exiting BS schemes of studies. processing the 2-Year Associate Degree Program and other related matters in light of the HEC UEP-2020 in order to ensure compliance of the subject captioned matter in the larger interest of the
